**A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF ELK GROVE AMENDING THE CITY OF ELK GROVE  
CONFLICT OF INTEREST CODE**

WHEREAS, on July 1, 2000 the City Council adopted Resolution No. 2000-14, adopting a Conflict of Interest Code incorporating 2 Cal. Code of Regulations Section 18730, containing the terms of a standard model conflict of interest code and any amendments made thereto; and

WHEREAS, the code was amended by Council Resolution No. 2002-200 on November 20, 2002 and by Resolution No. 2004-302 on December 15, 2004 by adding positions required to report; and

WHEREAS, as a result of the review mandated by Government Code Section §87306.5 it has been determined that the list of designated positions appended thereto should be revised.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. All provisions of the Conflict of Interest Code adopted by the City Council by Resolution No. 2000-14 shall remain in effect.
2. The list of designated positions is amended, as attached.



I. Designated Positions.

The individual occupying each position is deemed to make, or participate in the making of, decisions, which may have a material effect on a financial interest of that individual. The individuals occupying the designated positions shall disclose their economic interests in accordance with the corresponding disclosure categories, defined in Section II below.

II. Disclosure Categories.

1. Category 1

Individuals in this category shall disclose all interests in real property located within the City and all investments in, business positions with, and sources of income from entities having an interest in real property within the City or entities which are of the type to do business with or within the City.

2. Category 2

Individuals in this category shall disclose all investments and business positions in business entities, and income from sources which: (1) are contractors or subcontractors engaged in the performance of work or

services of the type utilized by the City, or (2) which manufacture or sell supplies, material, machinery or equipment of the type utilized by the City.

3. Category 3

Individuals in this category shall disclose all investments and business positions in business entities, and income from sources which: (1) are contractors or subcontractors engaged in the performance of work or services of the type utilized by the designated employee's department, or (2) which manufacture or sell supplies, material, machinery or equipment of the type utilized by the designated employee's department.

II. Disclosure Categories.

1. Category 1

2. Category 2

Individuals in this category shall disclose all investments and business positions in business entities, and income from sources which: (1) are contractors or subcontractors engaged in the performance of work or services of the type utilized by the City, or (2) which manufacture or sell supplies, material, machinery or equipment of the type utilized by the City.

3. Category 3

Individuals in this category shall disclose all investments and business positions in business entities, and income from sources which: (1) are contractors or subcontractors engaged in the performance of work or services of the type utilized by the designated employee's department, or (2) which manufacture or sell supplies, material, machinery or equipment of the type utilized by the designated employee's department.


