**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING NEGOTIATION OF A CONTRACT WITH KEENAN & ASSOCIATES  
FOR BROKERAGE CONSULTING SERVICES**

**WHEREAS**, ensuring the employees of the City receive quality benefits that meet their needs and contribute to a healthy work environment; and

**WHEREAS**, improvement to the City's benefit plans may increase effectiveness of recruitment strategies; and

**WHEREAS**, the City's growth, needs, and employee base has outgrown the City's current benefits brokerage services; and

**WHEREAS**, staff has determined through a competitive selection process that Keenan and Associates is best qualified to carry out the brokerage services of this contract.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to negotiate and execute a contract with Keenan & Associates for brokerage consulting services for an amount not to exceed \$25,000 which is based on the commissions paid to the City's existing broker.



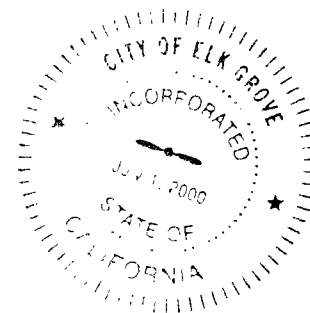
