A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ELK GROVE, TO EXECUTE A PROFESSIONAL SERVICES CONTRACT WITH BLAIS & ASSOCIATES FOR AN AMOUNT NOT TO EXCEED \$46,000 FOR GRANT WRITING SERVICES, AND AMEND THE FY 2006-07 POLICE DEPARTMENT BUDGET

WHEREAS, The Elk Grove Police Department provides the full range of public safety programs and enforcement for the City; and

WHEREAS, Funding for police activities is derived primarily from the City's general fund; and

WHEREAS, a wealth of grant funding opportunities are available for national security and public safety related activities; and

WHEREAS, a Request For Proposal for grant writing services was issued with a closing date of December 29, 2006; and

WHEREAS, Blais & Associates was selected for their extensive experience in working with public agencies, their specified approach to grant research, and success in grant attainment; and

WHEREAS, the total value of the contract with Blais & Associates will not exceed \$46,000 for one year. It is estimated that \$18,000 will be expended in the current fiscal year; and;

WHEREAS, funding in the amount of \$18,000, will be transferred from the General Fund contingency to the Police Department budget to cover grant activities for the remainder of fiscal year 2006-07. The remaining \$28,000 will be addressed in the FY 2007-08 Police Department budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove:

1. That the recitals set forth in this resolution are hereby adopted as true and correct.

2. That the City Manager, or his designee is authorized to negotiate and execute a professional services contract on behalf of the City with Blais and Associates for an amount not to exceed \$46,000.

3. That the City Manager is hereby authorized and directed to execute budgetary expenditures in the amount, and subject to the terms, set forth in the recitals to this resolution.
