## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE MAYOR TO EXECUTE AN EASEMENT FOR SEWER PURPOSES OVER A PORTION OF CITY-OWNED LOT B OF SUBDIVISION NO. 04-764.01 THE GROVE AT LAGUNA RIDGE VILLAGE 1

WHEREAS, the City of Elk Grove is fee owner of Lot B as shown on the Map of Subdivision No. 04-764.01 The Grove at Laguna Ridge Village 1 filed in Book 358 of Maps at Page 13, Official Records of Sacramento County; and

WHEREAS, this Lot B is a Landscape Corridor dedicated in Fee Simple to the City of Elk Grove located on the east side of Bruceville Road between Barcella Drive and Civic Center Drive over the path of a Sewer Force Main Project that has been constructed as part of the City's Laguna Ridge Specific Plan; and

WHEREAS, the construction of this Sewer Force Main and its appurtenances necessitates the dedication to County Sanitation District No. 1 (CSD-1) of a perpetual Right-of-Way and Maintenance Easement over a portion of Lot B; and

WHEREAS, the purpose of this Resolution is to authorize the Mayor of the City of Elk Grove to execute an Easement for Sewer Purposes to CSD-1, subject to the City's fee ownership; and

WHEREAS, staff has reviewed this easement and recommends the Mayor be authorized to execute the sewer easement.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds:

- a. This easement for sewer purposes over a portion of City-owned property would be consistent with and not violate the General Plan and all elements and components thereof; and
- b. The public interest will be served by the granting of this sewer easement.

**NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED** that the Mayor of the City of Elk Grove is hereby authorized to execute on behalf of the City, the Grant Deed for this Sewer Easement; and

NOW, THEREFORE, BE IT FINALLY RESOLVED AND ORDERED that the Clerk of the City of Elk Grove shall cause a certified copy of this Resolution authorizing the Mayor to execute said Easement for sewer purposes over portions of City-owned property, attested by the Clerk under seal, to be recorded in the office of the County Recorder of the County of Sacramento.
