## **RESOLUTION NO. 2007-169**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE PURCHASE OF 60 NEW DELL COMPUTER SYSTEMS FROM DELL COMPUTERS, INC. THROUGH THE WESTERN STATES CONTRACTING ALLIANCE FOR AN AMOUNT NOT-TO-EXCEED \$70,000

WHEREAS, the City has identified outdated computer systems in use by City staff to conduct daily business, and

WHEREAS, these outdated systems will not be able to comply with updates scheduled to be made by HTE, the City's government software, in August 2007 and could hinder the City's ability to efficiently provide services to the public, and

WHEREAS, the City has determined the need to replace the outdated systems by purchasing 60 new computer systems from Dell Computers, Inc. through the Western States Contracting Alliance (WSCA), and

WHEREAS, the City Council has the authority pursuant to Ordinance No. 6-2007 to forego a competitive bid process and make the purchase through WSCA to avoid unnecessary delay under the circumstances, and

**WHEREAS**, the purchase of new computer systems in an amount not-to-exceed \$70,000 is included in the approved Fiscal Year 2007-08 budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the purchase of 60 new Dell computer systems from Dell Computers, Inc. for an amount not-to-exceed \$70,000.
