A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE GRANTING SACRAMENTO MUNICIPAL UTILITY DISTRICT (SMUD) AN OVERHEAD ELECTRIC EASEMENT OVER A CITY OWNED DRAINAGE CHANNEL (PW-07-9006)

WHEREAS, the City of Elk Grove was granted a drainage channel from the County of Sacramento in January 2005;

WHEREAS, the channel is in use for carrying of drainage waters as part of the City's drainage system;

WHEREAS, SMUD is constructing a 69 kilovolt (KV) power line along Laguna Boulevard through the Apple Computer Inc. site thence along an existing SMUD easement parallel with the City's drainage channel and is desirous of obtaining an easement across the City's drainage channel in conjunction with said construction;

WHEREAS, City staff has reviewed the documents for the easement grant and is satisfied that language in the easement document does not interfere with the City's complete and free use of the channel as the easement is for overhead lines only; and

WHEREAS, City staff hereby recommends the City grant the attached easement to SMUD.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby grants to Sacramento Municipal Utility District the attached easement as described in "Exhibit A" and shown on the "Plat to accompany the legal description" in "Exhibit B" and directs the Mayor to sign the attached easement document and record it in the office of the County Recorder of the County of Sacramento.

GRANT OF EASEMENT

TOGETHER WITH a right of way therefore over that certain real property situate in the County of Sacramento, State of California, described herein.

Said right includes the trimming by Grantees of any trees or foliage along said easement whenever considered necessary for the complete enjoyment thereof and the right of ingress to and egress from said easement for the purpose of exercising and performing all rights and privileges granted herein.
