A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE SUMMARY ABANDONMENT OF A PORTION OF INGRESS AND EGRESS RIGHTS FOR THE WATERMAN SQUARE PROJECT (EG-05-861.00)

WHEREAS, the City of Elk Grove had been granted ingress and egress rights to Waterman Road on the Parcel Map entitled "Parcel Map No. EG-05-861.00, Waterman Square" filed in Book 199 at page 2, Official Records of Sacramento County except for a twenty (20) foot wide opening for a future driveway;

WHEREAS, in the current improvement plans for this project it is necessary for the driveway width to be thirty-five (35) feet wide; and

WHEREAS, this is consistent with the policies, standards and procedures of the City of Elk Grove.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds:

- a. Pursuant to Section 65402 of the Government Code, the abandonment is consistent with the General Plan;
- b. The abandonment is being made under the Streets and Highway Code Section 8335;
- c. The ingress and egress rights being abandoned are adjacent to the public street known as Waterman Road and are shown on the attached Exhibit's "A" and "B"; and
- d. These ingress and egress rights are defined in Section 8308 of the Streets and Highway Code and can be Summarily Abandoned under Section 8334 (b) of said Code.

NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED that the portion of the ingress and egress rights as described in Exhibit "A" and shown on Exhibit "B" (plat to accompany legal description) **are hereby abandoned** as of the date of the recordation of this Resolution.

NOW, THEREFORE, BE IT FINALLY RESOLVED that the City Clerk of the City of Elk Grove shall cause a certified copy of this Resolution of Abandonment and Exhibits "A" and "B" attached hereto attested by the Clerk under seal, to be recorded in the Office of the County Recorder of the County of Sacramento.


AREA 2
