

**RESOLUTION NO. 2008-240**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO  
THE FRANCHISE AGREEMENT WITH ALLIED WASTE SERVICES OF NORTH  
AMERICA, LLC FOR RESIDENTIAL REFUSE COLLECTION AND  
TRANSPORTATION TO DISPOSAL FACILITIES AND RECYCLABLES AND GREEN  
WASTE COLLECTION, TRANSPORTATION, PROCESSING AND MARKETING**

**WHEREAS**, the City of Elk Grove entered into a Franchise Agreement with Allied Waste Services of North America, LLC (“Allied Waste”) on April 23, 2004; and

**WHEREAS**, Allied Waste will now provide additional programs as outlined in the Third Amendment to the Franchise Agreement; and

**WHEREAS**, Allied Waste will provide E-Waste collection from residential premises by appointment and without surcharge to the residential customer or the City of Elk Grove; and

**WHEREAS**, Allied Waste will provide four (4) roll-off containers to City locations as designated by City staff and will provide eight (8) roll-off containers as designated by Code Enforcement to remove solid waste from a premise that is issued a notice and order without surcharge to the City of Elk Grove; and

**WHEREAS**, Allied Waste will provide receptacles for refuse and recyclables at eleven community events, without surcharge to the sponsoring organization or to the City of Elk Grove; and

**WHEREAS**, Allied Waste will provide roll-off containers for refuse, green waste and recyclables at the City of Elk Grove’s Corporation Yard as directed by City staff, and will automatically service refuse and recyclable carts on a weekly basis and will provide trash and recycle services to all City facilities at no charge to the City of Elk Grove; and

**WHEREAS**, if Allied Waste is directed to pick up carts from accounts, as directed by the City, and then has to redeploy the carts back to the same location, they will be entitled to compensation as listed in the Third Amendment.

**NOW, THEREFORE, BE IT RESOLVED** that the City Manager is hereby authorized to execute the Third Amendment to the Franchise Agreement between the City of Elk Grove and Allied Waste Services of North America, LLC.
