

**RESOLUTION NO. 2008-228**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPOINTING  
KEN CROSS, JOHN COSTA, RACHEL ISKOW, AND MICHAEL CRAIG NAGLER AS  
MEMBERS OF THE AFFORDABLE HOUSING LOAN COMMITTEE**

**WHEREAS**, on November 14, 2007 the City Council approved Resolution No. 2007-261 authorizing the formation of the Affordable Housing Loan Committee in order to protect the health, safety, and welfare of the community and ensure that adequate housing for very low and low income households is provided in the City of Elk Grove, as the City provides loans to developers of affordable housing projects to assist in construction financing; and


**WHEREAS**, the committee will be a standing committee which consists of three members. Each member and designated alternates must be approved by a majority vote of the City Council; and

**WHEREAS**, the first member of the committee will be the City's Finance Director or his or her designee.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby appoints Ken Cross and John Costa as members of the Affordable Housing Loan Committee representing a non-profit affordable housing advocacy group and the Northern California Building Industry Associated respectively; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby appoints Rachel Iskow and Michael Craig Nagler as alternate members of the Affordable Housing Loan Committee representing a non-profit affordable housing advocacy group and the Northern California Building Industry Associated respectively.
