

**RESOLUTION NO. 2008-47**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE  
DISPOSAL OF HOUSEHOLD BATTERIES AT THE CITY OF SACRAMENTO'S  
PERMANENT HOUSEHOLD HAZARDOUS WASTE COLLECTION FACILITY**

WHEREAS, the City of Sacramento operates a permitted Permanent Household Hazardous Waste Collection Facility (PHHWCF) capable of providing access to Elk Grove residents; and

WHEREAS, the City of Elk Grove does not currently own a facility enabling Elk Grove residents to dispose of household hazardous waste; and

WHEREAS, the County of Sacramento and the City of Elk Grove has had a contractual agreement since July 2002, enabling the City of Elk Grove residents to utilize its household hazardous waste collection facility at 8491 Fruitridge Road; and


WHEREAS, the current contract does not allow for the City of Elk Grove's Integrated Waste department to dispose of the large volume of household batteries collected throughout the City's battery drop-off locations on a weekly basis, to be disposed of at the City of Sacramento's PHHWCF.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes a three year agreement with the City of Sacramento generally with the terms as identified in the attached agreement; and,

BE IT FURTHER RESOLVED that the City Manager or his/her designee is hereby authorized and empowered to negotiate terms and execute in the name of the City of Elk Grove an agreement and payments as requested and amendments hereto for the purposes of providing proper disposal of household hazardous waste for the residents of Elk Grove, in a form acceptable to the City Attorney.


