**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO AMEND THE FISCAL YEAR 2007-2008
TRANSPORTATION DEVELOPMENT ACT (TDA) CLAIM AND AUTHORIZE
SUBMISSION TO SACRAMENTO AREA COUNCIL OF GOVERNMENTS (SACOG)
FOR UNCLAIMED STATE TRANSIT ASSISTANCE (STA) FUNDS AND THE
REDIRECTION OF PREVIOUSLY AUTHORIZED EXPENDITURES OF LOCAL
TRANSPORTATION FUNDS (LTF) AND STA FUNDS**

WHEREAS, the State of California enacted the Transportation Development Act (TDA) in 1972 to provide funds for transportation needs each fiscal year; and

WHEREAS, the Sacramento Area Council of Governments (SACOG) is designated as the Regional Transportation Planning Agency for the six county metropolitan area, which includes the City of Elk Grove, to receive claims for approval pursuant to the TDA rites and regulations; and

WHEREAS, SACOG has adopted findings of apportionment for State Transit Assistance Funds and Local Transportation Funds for Fiscal Years 2004-2005, 2005-2006, 2006-2007, 2007-2008 for Sacramento County.

NOW, THEREFORE, BE IT RESOLVED that the City Manager is hereby authorized to submit an amended Fiscal Year 2007-2008 TDA to SACOG for the distribution of unclaimed STA funds, and the redirection of LTF and STA funds.


