## **RESOLUTION NO. 2008-89**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING COVERAGE FOR ALL CITY OFFICERS AND EMPLOYEES UNDER ONE MASTER COMMERCIAL GOVERNMENT CRIME INSURANCE POLICY

WHEREAS, state law requires a surety bond for the City Clerk and the City Treasurer; and

WHEREAS, the City Council may require bonds of other officers or employees of the City, and

**WHEREAS**, Government Code section 1481 allows a city to use a master bond to cover all of its officers and employees; and

WHEREAS, Government Code section 1463 allows a city to use a commercial government crime insurance policy or employee dishonesty policy to cover all of its officers and employees, which will provide even broader and more cost-effective coverage than a crime bond, and

WHEREAS, approval of this resolution would eliminate the necessity of writing bonds on specifically named individuals for their term of office, reducing both cost and paperwork;

**NOW, THEREFORE, BE IT RESOLVED** that the form of such a master commercial government crime insurance policy shall meet the following minimum form standards:

- 1. The amount shall not be in amount less than \$1,000,000.
- 2. The insurance policy shall be issued by a company authorized to do business in the State of California.
- 3. The insurance policy shall be issued by a company with a Best's rating of no less than A:VII.
- 4. The insurance policy shall encompass claims for forgery or alteration; theft, disappearance, or destruction; robbery and safe burglary; public employee dishonesty; computer fraud; and fund transfer fraud.
- 5. The form of the policy shall be subject to approval by the City Manager or his designee.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove authorizes the coverage of all their officers and employees under one master commercial government crime insurance policy with the adoption of this resolution, and

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby repeals Resolution No. 2000-5.
