## **RESOLUTION NO. 2008-77**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE ELK GROVE (OLD TOWN) LIBRARY PROJECT EXEMPT FROM THE CEQA AND DIRECTING THE FILING OF A NOTICE OF EXEMPTION, AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT FOR AN AMOUNT NOT TO EXCEED \$2,245,000 WITH HOWARD S. WRIGHT CONSTRUCTORS, AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$245,000, AND AMENDING THE FISCAL YEAR 2007-08 BUDGET AND THE 2007-2012 CAPITAL IMPROVEMENT PROGRAM WHICH INCREASES THE PROJECT BUDGET FROM \$6,950,000 TO \$8,190,200

WHEREAS, the City of Elk Grove purchased the office building at the corner of Elk Grove Boulevard and Elk Grove-Florin Road with the intention of converting it into a public library;

WHEREAS, the design of the conversion has been completed and approved by the Library Authority and reviewed with the public and the City Council to assure a functional and useful library;

**WHEREAS**, the California Environmental Quality Act (CEQA) Section 15301 (a) exempts projects that involve interior construction including partitions, plumbing and electrical work from environmental review;

WHEREAS, the funding for the project has been identified as \$4,600,000 from County Library Authority funds and \$2,350,000 in City Library Capital Facilities Fee (CFF) funds and requires an amendment to the Fiscal Year 2007-08 Budget and the 2007-2012 Capital Improvement Program;

WHEREAS, this amendment would increase the total project budget from \$6,950,000 to \$8,190,200;

WHEREAS, on February 15, 2008 the City advertised for bids for construction of the library; and

WHEREAS, on March 11, 2008, Howard S. Wright Constructors submitted the lowest responsive bid as a participant in a public competitive bidding process.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

1. Finds that the Elk Grove (Old Town) Library Project (Capital Improvement Project ID PF0011) is exempt from the CEQA pursuant to section 15301 (a) because the

Resolution No. 2008-77 Page 1 of 2 work is interior construction. City staff is hereby directed to file a Notice of Exemption with the Sacramento County Recorder within 10 days of the passage of this resolution;

- 2. Authorizes the City Manager to execute a construction contract with Howard S. Wright in the amount of \$2,245,000 for the Project;
- 3. Authorizes the City Engineer to approve change orders not-to-exceed \$245,000; and
- 4. Approves the amendment to the Fiscal Year 2007-08 budget and the 2007-2012 Capital Improvement Program which increases the project budget from \$6,950,000 to \$8,190,200, reflecting \$4,600,000 from County Library Authority and \$3,590,200 in City Library Capital Facilities Fee Funds.
