

**RESOLUTION NO. 2008-124**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPOINTING CHARTER COMMISSIONERS**

**WHEREAS**, on March 26, 2008 the City Council adopted Resolution 2008-74 establishing the Charter Commission to draft a charter for consideration by the City Council for presentation to the voters of the City of Elk Grove at the November 2010 General Election; and

**WHEREAS**, Resolution 2008-74 also established that the Charter Commission shall consist of seven members; and


**WHEREAS**, each member of the City Council shall appoint one member to the Commission with the remaining two members appointed at-large by a majority vote of the City Council.
