RESOLUTION NO. 2008-147

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AN ADJUSTMENT IN RESIDENTIAL COLLECTION AND DISPOSAL SOLID WASTE SERVICE RATES

WHEREAS, the City Council of the City of Elk Grove approved a Franchise Agreement with Allied Waste for the collection, transport and disposal of residential trash and the collection, transport, processing and marketing of recyclables and green waste; and

WHEREAS, under the Franchise Agreement, Allied Waste is entitled to an annual compensation adjustment reflecting changes in specified indices, including the Consumers Price Index and Producers Price Index for motor fuel; and

WHEREAS, the City of Elk Grove is in compliance with Article XIIID of the California State Constitution and the Proposition 218 Omnibus Implementation Act, the City of Elk Grove notified all affected property owners and ratepayers of the proposed solid waste rate increases and the City did not receive a majority protest; and

WHEREAS, the City Council of the City of Elk Grove understands the need to adjust residential customer service rates to reflect changes in Allied Waste's compensation; does not want to burden the General Fund with these costs incurred on behalf of residential customers; and pursuant to authority, including Section 40059 of the Public Resources Code, has provided in Article 5 of Chapter 6.20 of the Elk Grove Municipal Code for establishing, revising, billing and collecting of residential solid waste handling service charges.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the rates in Exhibit A: Year 5 Solid Waste Rates of the monthly solid waste handling service charges to residents effective July 1, 2008.
