## **RESOLUTION NO. 2008-155**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2007-08 BUDGET AND ALLOCATING ADDITIONAL APPROPRIATIONS IN THE AMOUNT OF \$1,620,000 TO THE TRANSIT DIVISION

WHEREAS, an analysis of the Transit budget projects overages in the Fiscal Year 2007-08 Budget caused by excessive expenditures related to maintenance, parts, and fueling of compressed natural gas (CNG) buses, additional staff, Paratransit services, and bonus programs to promote safety; and

WHEREAS, after reallocating funds, completing budget transfers and moving allowable Federal Transit Assistance capital funds to operations, additional appropriations are needed totaling \$1,620,000 to meet estimated current fiscal year financial obligations at current service levels and vendor charges; and

WHEREAS, there is no fund balance or planned revenues to offset these expenses.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby declares:

- 1. The recitals set forth in this resolution are true and correct.
- 2. The City Council authorizes an amendment to the Fiscal Year 2007-08 Budget and authorizes additional budget appropriations in the Transit division, in the amount of \$1,620,000 as set forth in Schedule 1 of this resolution.
