

**RESOLUTION NO. 2008-177**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING AN AMENDMENT TO THE 2008-2013 CAPITAL IMPROVEMENT  
PROGRAM TO INCLUDE THE ELK GROVE-FLORIN ROAD AND BROWN  
ROAD/SILVERBERRY AVENUE TRAFFIC SIGNAL AND INTERSECTION  
IMPROVEMENT PROJECT**

**WHEREAS**, Elk Grove residents have raised concern about the ability to traverse Elk Grove-Florin Road due to existing concrete medians; and

**WHEREAS**, Elk Grove City staff has worked with residents in developing a project to address these concerns and improve safety and accessibility for pedestrians and e-tran riders; and


**WHEREAS**, the proposed project, the Elk Grove-Florin Road and Brown Road/Silverberry Avenue Improvement Project would involve installation of a traffic signal and related pedestrian improvements; and

**WHEREAS**, the Elk Grove-Florin Road and Brown Road/Silverberry Avenue Improvement Project is an eligible project in the Elk Grove Roadway Fee Program; and

**WHEREAS**, the project cost is \$330,000 and, if constructed, would address the concerns and needs of the residents for pedestrian safety and improved traffic operations.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove approves an amendment to the 2008-2013 Capital Improvement Program to include the Elk Grove-Florin Road and Brown Road/Silverberry Avenue Traffic Signal and Intersection Improvement Project.


