

RESOLUTION NO. 2008-180

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT SERVICES
CONTRACT WITH URS CORPORATION FOR THE ELK GROVE CREEK TRAIL
CROSSING AT STATE ROUTE 99 PROJECT IN AN AMOUNT NOT TO EXCEED
\$945,015**

WHEREAS, there is need for a pedestrian/bicycle trail crossing at State Route 99 to connect existing segments of the City's trail system; and

WHEREAS, the need has been identified in local and regional planning documents and is supported by local trail users and advocates; and

WHEREAS, the preparation of planning and design documents for the project is identified in the City of Elk Grove's 2008-2013 Capital Improvement Program; and


WHEREAS, a Request for Proposals was advertised in February 2008; and

WHEREAS, eight proposals were received on March 5, 2008 and were reviewed and ranked by City staff; and

WHEREAS, City staff conducted subsequent interviews with the top four firms and determined through a competitive, qualifications based selection process that URS Corporation is best qualified to carry out the consultant services required for this project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant services contract with URS Corporation in an amount not to exceed \$945,015 for the Elk Grove Creek Trail Crossing at State Route 99 Project.


