

**RESOLUTION NO. 2008-190**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT SERVICES CONTRACT AMENDMENT WITH QUINCY ENGINEERING, INC. FOR THE WEST STOCKTON BOULEVARD AT LAGUNA CREEK BRIDGE REPLACEMENT PROJECT TO EXTEND THE TERMINATION DATE TO DECEMBER 31, 2009**

**WHEREAS**, the West Stockton Boulevard at Laguna Creek Bridge Replacement Project (Project) involves replacing the existing two-lane bridge with a widened bridge to provide room for bike lanes and allow for a southbound right-turn lane into adjacent residential development. The bridge profile will also be raised and the Laguna Creek Channel will be widened to better accommodate high flows in Laguna Creek; and

**WHEREAS**, the federal funding authorization was delayed resulting in a delay to the construction advertising date; and

**WHEREAS**, the delay in funding resulted in delaying the construction advertising date to winter of 2008; and


**WHEREAS**, consultant bidding assistance and construction support is required for the project; and

**WHEREAS**, the current consultant services contract with Quincy Engineering, Inc. for preparation of construction documents and related engineering support for the Project was approved by City Council on July 21, 2004 (Resolution No. 2004-171) and will expire December 31, 2008; and

**WHEREAS**, the new extended termination date of December 31, 2009 will enable Quincy Engineering, Inc. to continue to provide necessary services for the Project including bidding assistance and construction support.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant services contract amendment with Quincy Engineering, Inc. for the West Stockton Boulevard at Laguna Creek Bridge Replacement Project to extend the termination date to December 31, 2009.


