A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE CITY OF ELK GROVE SHORT RANGE TRANSIT PLAN TO ADD FOUR PROJECTS TO THE CAPITAL PROGRAM FOR FISCAL YEAR 2008-09

WHEREAS, additional transit revenue sources have become available that were unanticipated at the time the City of Elk Grove's Short Range Transit Plan was adopted; and

WHEREAS, potential capital projects must be included in the Short Range Transit Plan Capital Program to be eligible for funding consideration; and

WHEREAS, the City of Elk Grove desires to pursue funding of four (4) potential capital projects.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the City of Elk Grove Short Range Transit Plan Capital Program for Fiscal Year 2008-09 to include the following projects:

| 4) Design and Construction of a Compressed Natural Gas Fueling Facility | \$ 1,700,000 |

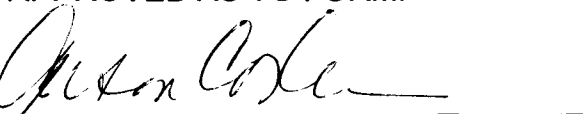

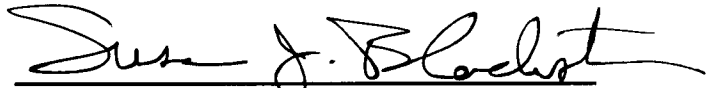
