RESOLUTION NO. 2009-49

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AN UPDATED PARKING VIOLATION FINE SCHEDULE THAT IMPLEMENTS CALIFORNIA STATE MANDATED SURCHARGES AS IDENTIFIED IN GOVERNMENT CODE 76000 AND SB1407 INCLUDING AN INCREASED PROOF OF CORRECTION FEE

WHEREAS, Government Code 76000 states that every parking penalty, fine, or forfeiture imposed, an added penalty of \$2.50 shall be collected for the local courthouse construction and criminal justice facilities fund; and

WHEREAS, Effective January 1, 2009, Senate Bill 1407 imposed an additional \$3 fee to Government Code 76000 and increased the Proof of Correction fee from \$10 to \$25; and

WHEREAS, The City of Elk Grove desires to pass along State mandated parking violation surcharges to motorists who park in violation of the law.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts an updated parking violation fine schedule attached hereto and incorporated herein that implements California State mandated surcharges as identified in Government Code 76000 and SB1407 including an increased Proof of Correction fee.
