

**RESOLUTION NO. 2009-160**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE FINANCE DIRECTOR TO EXERCISE THE SALE AND  
DISPOSAL OF SURPLUS CITY PROPERTY IN THE FORM OF POLICE  
MOTORCYCLES, LAW ENFORCEMENT EQUIPMENT, AND A SEDAN**

**WHEREAS**, in October 2005, the City Council approved the purchase of eleven (11) Harley Davidson Road King Motorcycles and related law enforcement equipment to be used by the newly formed Elk Grove Police Department, three (3) of which have already been surplused; and

**WHEREAS**, the City purchased a 1998 Ford Taurus sedan to be used by Transit to shuttle drivers on local routes; and

**WHEREAS**, staff has designated the remaining eight (8) police motorcycles and the sedan as surplus, as they have reached the end of their service life based on years in service and/or mileage; and

**WHEREAS**, police motorcycles are equipped with emergency response equipment that must be removed prior to public sale; and

**WHEREAS**, Elk Grove Municipal Code Chapter 3.42 specifies the terms and conditions for the disposition of surplus City property; and

**WHEREAS**, the City of Elk Grove desires to surplus eight (8) police motorcycles, their emergency response equipment, and a four door sedan, and sell or dispose of the assets at fair market value.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the Finance Director to exercise the sale or disposal of surplus City property in the form of a four-door sedan, eight (8) police motorcycles, including the disposal of their associated emergency response equipment through sale to other law enforcement agencies, reuse by the City, or designation as unsalvageable, based on the needs of the City. The description of these items is shown in Exhibit "A" to this resolution, incorporated herein by this reference.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that proceeds from the sale or disposal of the surplus sedan, police motorcycles, and equipment will be deposited into the Facilities and Fleet Internal Services Fund and Transit Fund, respectively.


