**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION
CONTRACT WITH FBD VANGUARD CONSTRUCTION FOR THE COMMUNITY
DEVELOPMENT BLOCK GRANT (CDBG) ACCESSIBILITY CURB, GUTTER AND
SIDEWALK IMPROVEMENTS PROJECT IN THE AMOUNT OF \$114,685.50
AND AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS
NOT TO EXCEED \$17,202.83**

WHEREAS, the Community Development Block Grant (CDBG) Accessibility Curb, Gutter and Sidewalk Improvements Project is included in the 2008-13 Capital Improvement Program and is budgeted within the approved Fiscal Year 2008-09 Budget; and

WHEREAS, an invitation to bid was duly advertised on September 16, 2009 and bids were opened on October 8, 2009; and

WHEREAS, FBD Vanguard Construction was determined to be the responsible bidder submitting the lowest responsive bid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a construction contract with FBD Vanguard Construction for the CDBG Accessibility Curb, Gutter and Sidewalk Improvements Project in the amount of \$114,685.50 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and
- 2) Authorizes the City Engineer to approve change orders not to exceed \$17,202.83.
