## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO REQUEST GRANTEE TRANSFER OF FEDERAL TRANSIT ADMINISTRATION FUNDED BUSES FROM UNITRANS TO THE CITY OF ELK GROVE TRANSIT DIVISION

WHEREAS, Unitrans has ten Bluebird buses that are no longer needed because a new order of replacement buses will be arriving in December 2009, earlier than the expected date of February 2011: and

WHEREAS, Unitrans purchased the Bluebird buses with Federal Transit Administration (FTA) funds; and

WHEREAS, the Bluebird buses have approximately 12 months remaining "useful life"; and

WHEREAS, the City of Elk Grove Transit Division has established an interest and need for these ten buses; and

WHEREAS, the Davis City Council has previously authorized their City Manager to request a grantee-to-grantee transfer of the ten FTA-funded, model year 2000, Bluebird buses.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Elk Grove hereby authorizes the City Manager to request a grantee-to-grantee transfer of ten FTA-funded, model year 2000 Bluebird buses that have not reached the end of their economically useful lives from the City of Davis and Unitrans as identified in the attached Exhibit A.
