## **RESOLUTION NO. 2009-239**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING ABANDONMENT OF A PORTION OF DRAINAGE EASEMENT OVER LOT A, FIELDSTONE UNIT NO. 38

WHEREAS, the City of Elk Grove was granted a drainage easement from the County of Sacramento over Lot A of Fieldstone Unit No. 3B; and

**WHEREAS**, the City has determined that the easement for drainage purposes is in excess of what is required for drainage purposes; and

**WHEREAS**, on November 19, 2009 the Planning Commission found this abandonment to be consistent with the City's General Plan.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds:

- 1) That this easement is defined under the Streets and Highway Code, Division 9, Part 3, Chapter 1, Section 8306 (a) as a "Public Service Easement'; and
- 2) That this portion of the easement may be summarily abandoned pursuant to the Streets and Highway Code, Division 9, Part 3, Chapter 4, Article 1, Section 8333 (c) since it has been determined that the easement is in excess of what is required for drainage purposes and there are no facilities within the easement area; and
- 3) The proposed abandonment is exempt from Environmental Review pursuant to the California Environmental Quality Act ("CEQA") under Article 5, Section 15061 (b) (3) because there is no possibility the activity in question may have a significant effect on the environment; and
- 4) That easement being abandoned is the entire easement over Lot A except for the area as described in Exhibit "A" and shown on Exhibit "B".

NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED that the drainage easement over Lot A, except for the area described in Exhibit "A" and shown on Exhibit "B" is hereby abandoned and that from and after the date of the recordation of this resolution the drainage easement no longer exists over Lot A except

for the area as described in Exhibit "A" and shown on Exhibit "B".

**NOW, THEREFORE, BE IT FINALLY RESOLVED** that the City Clerk of the City of Elk Grove shall cause a certified copy of this Resolution of Abandonment and Exhibits "A" and "B" attached hereto attested by the Clerk under seal, to be recorded in the Office of the County Recorder of the County of Sacramento.


