A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AND** RELATED DOCUMENTS TO WILLDAN FINANCIAL SERVICES TO PROVIDE FINANCING DISTRICT ADMINISTRATION SERVICES

WHEREAS, the City needs financing district administration services in the routine course of business; and

WHEREAS, City Staff solicited proposals from all interested parties; and

WHEREAS, multiple proposals were received and evaluated; and

WHEREAS, the proposal submitted by Willdan Financial Services is the most responsive.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Awards the financial advisory services contract to Willdan Financial Services. The Consultant shall be paid on a quarterly basis, per Exhibit A, attached hereto and incorporated herein, for annual administration and other services. For Fiscal Year 2009-10, monies are appropriated for such services within the current budget. Future costs for services will be addressed in future budgets.
- 2) Authorizes the City Manager to execute related documents.

Optional Supplemental Reports

Spending Exception Analysis: If bond issue proceeds are spent within a specific timeframe, regulations offer few exceptions to the Arbitrage Rebate rules. If Willdan's bonds' Consultant's Report indicates a positive rebate liability has accrued, these exceptions to rebate will be explored, as they relate to the bonds. If these exceptions to rebate appear to provide a favorable alternative, an additional calculation stating these results will be prepared. The fees to prepare a calculation relating to the appropriate spending exception will be separate from the above-stated fees and will be discussed prior to pursuing these opportunities.

<u>Variable Rate Yield Optimization</u>. Regulations allow the issuer of variable rate debt to separately compute yield for each bond year. At the end of the first five (5) bond years, the issuer may use the most advantageous combination of bond years to compare bond yield, to investment yield. If desired, Willdan will prepare an additional calculation to determine the optimal combination of periods that achieve the lowest possible rebate payment. The fee to prepare this analysis will be separate from the above-stated fees and will be discussed prior to pursuing this opportunity.

Evidence of Due Diligence: In many cases, a tax-exempt bond will meet an exception to the Arbitrage Rebate and yield-restriction regulations, whereby only evidence of due diligence is required indicating that Section 148 of the IRS regulations has been considered. If requested by the City, a summary letter documenting the issuer's discovery efforts will be prepared. The fee for this service is \$500.

Billing Practices

Upon completion of the reports, Willdan will submit an invoice for rendered services. It is intended that the City make payments to Willdan Financial Services within thirty (30) days of invoicing. Willdan cannot accept credit card payments.

Financial Consulting Services (1)

Financial consulting services may be authorized by the City and will be billed at the hourly consulting rates noted in the "Additional Services" section. The consultant will only proceed with written authorization from City staff on tasks indicated under "Financial Consulting Services." All services under the specific task will be billed, based on hourly expenses. For annexations, an additional cost per map sheet will apply.

Based on project hours performed and incurred out-of-pocket expenses, Willdan will bill on a monthly basis.

Reimbursable Expenses

Willdan will be reimbursed for out-of-pocket expenses, not to exceed the amounts presented in the preceding tables. Examples of reimbursable expenses include, but are not limited to: postage, travel expenses, mileage (55¢ per mile),

maps, electronic data furnished from the County and/or other applicable resources, construction cost periodicals, and copying (currently 6¢ per copy). Any additional expense for reports or from outside services will be billed to the City. Charges for meeting and consulting with counsel, the City, or other parties regarding services not listed in the scope of work will be at the hourly consulting rates noted in the "Additional Services" section. In the event that a third party requests any documents, Willdan may, in accordance with Willdan's applicable rate schedule, charge such third party for providing these documents.

Our fees will <u>not</u> be contingent upon the sale of bonds. To cover costs, we recommend the City continue the practice of obtaining a deposit from developers for annexations and formations.
