

**RESOLUTION NO. 2010-22**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE MAYOR TO EXECUTE A DEED GRANTING THE COSUMNES  
COMMUNITY SERVICES DISTRICT JOINT OWNERSHIP OF PROMENADE PARK IN  
THE LAGUNA RIDGE SPECIFIC PLAN AREA**

**WHEREAS**, the City of Elk Grove approved the Laguna Ridge Specific Plan (Plan) on June 14, 2004 as Resolution No. 2004-143; and

**WHEREAS**, consistent with the Plan, the Del-Webb Village 1 Subdivision Map approved on November 8, 2006 by Resolution No. 2006-280 created Lot G as a community park site, upon with the park known as Promenade Park has been constructed, accepted, and granted to the City in fee simple; and

**WHEREAS**, pursuant to City Agreement C-07-405, the City and the Cosumnes Community Services District (CCSD) are to jointly own and the CCSD is to maintain parks within the Plan area, except for Civic Center Park; and

**WHEREAS**, consistent with the aforementioned agreement, the City desires to transfer a fifty percent (50%) interest in Promenade Park to the CCSD.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds that the action of granting shared ownership of Promenade Park to the CCSD does not authorize nor commit the City to any activity which would result in a direct or indirect physical change in the environment and as a result is exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA guidelines Section 15061 (b) (3).

**NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED** that the City Council hereby authorizes and directs the Mayor to execute the attached deed, shown as Exhibit A, granting joint ownership to the CCSD to Lot G - Promenade Park and directs the City Clerk to cause the executed deed to be transmitted to the CCSD with instructions to have the deed recorded in the office of the County Recorder of Sacramento County once the deed has been executed by the CCSD.


