A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH EMERGENCY VEHICLE OUTFITTERS FOR INSTALLATION AND REPAIR OF EMERGENCY RESPONSE EQUIPMENT AND SAFETY LIGHTING FOR CITY VEHICLES FOR A TERM OF THREE YEARS IN A TOTAL AMOUNT NOT TO EXCEED \$530,000

WHEREAS, emergency response equipment and safety lighting is necessary on City vehicles in order to deliver services to the citizens of Elk Grove; and

WHEREAS, the City has conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements within the City's contracts and purchasing ordinance (Elk Grove Municipal Code Chapter 3.42); and

WHEREAS, Emergency Vehicle Outfitters met all of the criteria in the request for proposal that was most advantages to the City; and

WHEREAS, Fleet Services has sufficient funding identified in its Fiscal Year 2010-11 operating budget for this service.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Emergency Vehicle Outfitters for the installation and repair of emergency response equipment and safety lighting for the City's vehicle fleet for a term of three years in a total amount not to exceed \$530,000.
