**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ELK GROVE-FLORIN ROAD / BROWN ROAD-SILVERBERRY
AVENUE TRAFFIC SIGNAL AND INTERSECTON IMPROVEMENTS PROJECT AS
COMPLETE AND AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE
OF COMPLETION AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION
WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on May 26, 2010, the City Council awarded the construction contract to Tim Paxin's Pacific Excavation, Inc. to construct the Elk Grove-Florin Road / Brown Road-Silverberry Avenue Traffic Signal and Intersection Improvements Project (Capital Improvement Project ID PT0091) (Project); and

WHEREAS, the Project will improve this intersection by installing traffic signals, upgrading curb ramps and sidewalk, and installing a bus pad and crosswalks; and


WHEREAS, Tim Paxin's Pacific Excavation, Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Tim Paxin's Pacific Excavation, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Elk Grove-Florin Road / Brown Road-Silverberry Avenue Traffic Signal and Intersection Improvements Project (Project) as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
