**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE EAST STOCKTON BOULEVARD / SHELDON ROAD PARK AND
RIDE LOT LANDSCAPING PROJECT AS COMPLETE AND AUTHORIZING
THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION AND
THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER**

WHEREAS, on March 23, 2011 the City Council authorized the award of a construction contract to Dominguez Landscape Services, Inc. to construct the East Stockton Boulevard / Sheldon Road Park and Ride Lot Landscaping Project (Capital Improvement Project ID PT10PR) (Project); and

WHEREAS, the Project provided for the installation of planting materials and irrigation systems, minor site improvements including installation of a traffic signal system at the entrance to the Park and Ride Lot, bicycle storage lockers and bus stop shelters along East Stockton Boulevard south of Sheldon Road including the Park and Ride Lot; and


WHEREAS, Dominguez Landscape Services, Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Dominguez Landscape Services, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the East Stockton Boulevard / Sheldon Road Park and Ride Lot Landscaping Project (Project) as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


