**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY  
DOCUMENTS TO AMEND THE CURRENT INTERNSHIP SERVICES CONTRACT  
WITH UNIVERSITY ENTERPRISES, INC., IN THE AMOUNT OF \$10,000 [FOR A  
TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$59,500]**

**WHEREAS**, the City of Elk Grove works with University Enterprises, Inc. to offer internship programs; and


**WHEREAS**, the City Council of the City of Elk Grove would like to offer internships to provide valuable experience to students in our community; and

**WHEREAS**, the dispensing with competitive bids for internship services is consistent with Elk Grove Municipal Code Chapter 3.42, and, in addition, there is no alternative vendor for these internship services; and

**WHEREAS**, the City Council of the City of Elk Grove recognizes that an internship program is a cost-effective way to offer assistance in developing new programs for the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the necessary documents to amend the current Internship Services contract with University Enterprises, Inc. in the amount of \$10,000 for a total compensation amount not-to-exceed \$59,500.


