

RESOLUTION NO. 2011-73

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES
CONTRACT WITH PACIFIC MUNICIPAL CONSULTANTS TO PROVIDE PLANNING
SERVICES FOR A TERM OF THREE YEARS WITH THREE (3) ADDITIONAL ONE
(1) YEAR EXTENSION OPTIONS**

WHEREAS, the City of Elk Grove utilizes consultants to perform most of the services within the Department of Planning; and

WHEREAS, the existing professional services contracts for Planning Services will expire on May 31, 2011; and

WHEREAS, a continuation of Planning Services is essential for processing development applications where a lapse of having a contract for these professional services is unacceptable; and


WHEREAS, the City has followed its purchasing ordinance requirements by issuing a Request for Proposals to solicit these services; and

WHEREAS, on March 4, 2011 proposals were received from four companies; and

WHEREAS, the proposal submitted by Pacific Municipal Consultants was determined to be the recommended proposal.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a professional services contract with Pacific Municipal Consultants to perform Planning Services for a term of three years with three (3) additional one (1) year extension options.


