

RESOLUTION NO. 2011-148

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT CONTRACT AMENDMENT WITH URS CORPORATION FOR THE ELK GROVE CREEK TRAIL CROSSING AT STATE ROUTE 99 IN THE AMOUNT OF \$84,415 AND EXTENDING THE CONTRACT TERM TO DECEMBER 31, 2013 [FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$1,029,430]

WHEREAS, the City of Elk Grove and URS Corporation (URS) entered into a consultant services contract for the Elk Grove Creek Trail Crossing at State Route 99 (Project) on July 23, 2008 (Contract No. C-08-220); and

WHEREAS, unforeseen delays with reviewing the Project related to the National Environmental Policy Act (NEPA) have delayed the project by 18 months; and

WHEREAS, the 18-month delay in obtaining NEPA environmental approval has resulted in the need for an additional 26 months of project management by URS for the Project; and


WHEREAS, new or updated requirements by agencies having jurisdiction and or unforeseen and unpredictable design circumstances have resulted in the need for additional professional services to be provided by URS to complete the Project design; and

WHEREAS, URS has agreed to provide these additional services for an amount not-to-exceed \$84,415; and

WHEREAS, the amendment would increase the total compensation allowed under the consultant contract from \$945,015 to \$1,029,430, which can be accommodated within the current approved project budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant contract amendment with URS Corporation for the Elk Grove Creek Trail Crossing at State Route 99 in the amount of \$84,415 for a total compensation amount not-to-exceed \$1,029,430 and extending the contract term to December 31, 2013.




