

**RESOLUTION NO. 2011-156**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
WAIVING THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PER  
ELK GROVE MUNICIPAL CODE SECTION 3.42.140 (B)(6) AND AUTHORIZING  
THE CITY MANAGER TO ENTER INTO A MASTER SERVICES CONTRACT  
WITH THE COSUMNES COMMUNITY SERVICES DISTRICT FOR PROJECT  
DELIVERY SERVICES IN AN AMOUNT NOT-TO-EXCEED \$200,000  
AS EXECUTED BY TASK ORDER**


**WHEREAS**, the Cosumnes Community Services District (CCSD) and the City have a shared interest in delivering projects that have landscaping, irrigation and other recreational value; and

**WHEREAS**, the CCSD has expertise in landscaping, irrigation and other recreational types of projects; and

**WHEREAS**, this work is not being solicited through a formal Request for Proposal (RFP) as required by Elk Grove Municipal Code Section 3.42.140 because: 1) the CCSD has the knowledge and experience to provide the type of services that the City does not offer; 2) the CCSD is currently under contract with the City to maintain these public facilities; and 3) the City and CCSD have a joint partnership in providing these facilities to the public.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby waives the formal Request for Proposal procedures pursuant to Elk Grove Municipal Code Section 3.42.140(B)(6) and authorizes the City Manager to enter into a Master Services Contract with the Cosumnes Community Services District for Project Delivery services in an amount not-to exceed \$200,000 as executed by task order.
