

RESOLUTION NO. 2011-183

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ASPHALT CONCRETE OVERLAY AND CURB RAMP
IMPROVEMENTS 2010 PROJECT AS COMPLETE AND AUTHORIZING THE CITY
ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE, THE NOTICE OF
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on May 26, 2010, the City Council awarded the construction contract to Granite Construction Company to construct the Asphalt Concrete Overlay and Curb Ramp Improvements 2010 Project (Capital Improvement Project ID PT3510) (Project); and

WHEREAS, the Asphalt Concrete Overlay and Curb Ramp Improvements 2010 Project provided asphalt overlay and pavement rehabilitation on various street segments throughout the City as part of the annual program. The pavement rehabilitation also included structural section removal and replacement where the existing pavement could not support an overlay. Additional work elements of the Project included replacement of curb returns with Americans with Disabilities Act (ADA) compliant handicap ramps, replacement of traffic signal detector loops, and new lane markings and striping; and


WHEREAS, Granite Construction Company has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Granite Construction Company.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Asphalt Concrete Overlay and Curb Ramp Improvements 2010 Project (Capital Improvement Project ID PT3510) (Project) as complete.


BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


