**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING  
THE FISCAL YEAR 2011-12 BUDGET FOR ANNEXATION EXPENSES AND

**WHEREAS**, the fees are for cost recovery of expenses related to annexation; and


**WHEREAS**, a project has duly paid its required annexation fees; and
