

RESOLUTION NO. 2011-239

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT CONTRACT
AMENDMENT WITH URS CORPORATION FOR THE ELK GROVE CREEK TRAIL
CROSSING AT STATE ROUTE 99 PROJECT IN THE AMOUNT OF \$54,700 [FOR A
TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$1,084,130]**

WHEREAS, the City of Elk Grove and URS Corporation (URS) entered into a consultant services contract for the Elk Grove Creek Trail Crossing at State Route 99 Project (Project No. PT0062) on July 23, 2008 (Contract No. C-08-220); and

WHEREAS, coordination between the City and Caltrans during final design has created the need for additional professional services for Reports of Investigation and shop drawing review previously unaccounted for; and

WHEREAS, the City desires to provide additional safety and accessibility features on the new trail bridge crossing State Route 99 in the form of cantilevered level landing areas at regular intervals; and

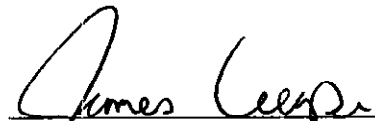
WHEREAS, additional design services are required to provide such level landing areas; and

WHEREAS, URS has agreed to provide all of these additional services for an amount not-to-exceed \$54,700; and

WHEREAS, the amendment would increase the total compensation allowed under the consultant contract from \$1,029,430 to \$1,084,130, which can be accommodated within the current approved project budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a consultant contract amendment with URS Corporation for the Elk Grove Creek Trail Crossing at State Route 99 Project in the amount of \$54,700 for a total compensation amount not-to-exceed \$1,084,130.
