**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE QUAIL RUN LANE AND BRUCEVILLE ROAD INTERSECTION
SOUTHWEST CORNER IMPROVEMENTS PROJECT AS COMPLETE AND
AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER**

WHEREAS, on October 26, 2011, the City Council awarded a construction contract to CW Fox Construction, Inc. to construct the Quail Run Lane and Bruceville Road Intersection Southwest Corner Improvements Project (Capital Improvement Project ID PT0112); and

WHEREAS, the Quail Run Lane and Bruceville Road Intersection Southwest Corner Improvements Project removed the existing asphalt concrete sidewalk and curb return at the southwest corner of the intersection of Quail Run Lane and Bruceville Road and replaced it with a new concrete sidewalk and curb return with Americans with Disabilities Act (ADA) compliant curb ramps; and


WHEREAS, CW Fox Construction, Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to CW Fox Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Quail Run Lane and Bruceville Road Intersection Southwest Corner Improvements Project (Capital Improvement Project ID PT0112) (Project) as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


