**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE NEIGHBORHOOD LIVABILITY (SPEED CONTROL)
IMPROVEMENT PHASE 2 AND PHASE 3 PROJECT AS COMPLETE AND
AUTHORIZING THE CITY ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE,
THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on November 9, 2011, the City Council awarded the construction contract to Vintage Paving Co. Inc. to construct the Neighborhood Livability (Speed Control) Improvement Phase 2 and Phase 3 Project (Capital Improvement Project ID WSC002 & WSC003); and

WHEREAS, the Neighborhood Livability (Speed Control) Improvement Phase 2 and Phase 3 Project (Project) will reduce speeding issues on various streets within the City by installing asphalt concrete speed humps and speed tables together with signing and striping; and


WHEREAS, Vintage Paving Co. Inc. has completed the work in accordance with the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Vintage Paving Co. Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Neighborhood Livability (Speed Control) Improvement Phase 2 and Phase 3 Project (Project) as complete.


BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


