

RESOLUTION NO. 2012-161

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING REQUIREMENTS PER ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH MAITA CHEVROLET OF ELK GROVE FOR THE PURCHASE OF TWO POLICE PURSUIT RATED CHEVROLET TAHOE VEHICLES IN AN AMOUNT NOT-TO-EXCEED A TOTAL OF \$73,000

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures additional vehicles when necessary; and


WHEREAS, the City of Mountain View, California recently opened a competitive bidding process for the purchase of Police Pursuit Rated Chevrolet Tahoe vehicles, and Coalinga Motors of Coalinga, California met all of the criteria and was selected as the lowest responsive responsible bidder; and

WHEREAS, staff contacted Maita Chevrolet of Elk Grove, who agreed to match the pricing of Coalinga Motors to purchase the Police Pursuit Rated Chevrolet Tahoes in Elk Grove; and

WHEREAS, it is the opinion of staff that formal bidding for the Police Pursuit Rated Chevrolet Tahoes would not be in the best interest of the City and that the expenditures of time and money will not result in an outcome more advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove determines that compliance with the bidding procedures for Police Pursuit Rated Chevrolet Tahoes is not in the best interest of the City, hereby dispenses with the formal bidding procedures pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3), and hereby authorizes the City Manager to execute a contract with Maita Chevrolet of Elk Grove for the purchase of two Police Pursuit Rated Chevrolet Tahoe vehicles in an amount not-to-exceed \$73,000.


