

RESOLUTION NO. 2012-192

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
OFFICIALLY NAMING SHED A CHANNEL AS EHRHARDT CHANNEL AND SHED B
CHANNEL AS FRANKLIN CREEK**

WHEREAS, staff explored officially naming two of the City's unnamed drainage channels at the request of City Council; and


WHEREAS, a naming committee (Committee) was formed consisting of two City staff members, one member of the Elk Grove Historic Preservation Committee and one member of the Elk Grove Trails Committee; and

WHEREAS, the Committee used the City of Elk Grove Facility Naming Policy (Policy) as a guide through the naming process; and

WHEREAS, the Committee unanimously agreed to propose the name of Ehrhardt Channel for Shed A Channel and Franklin Creek for Shed B Channel, each based upon their historical association to the City and consistent with the Policy.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby officially names Shed A Channel as Ehrhardt Channel and Shed B Channel as Franklin Creek as shown on the maps attached as Exhibit A.

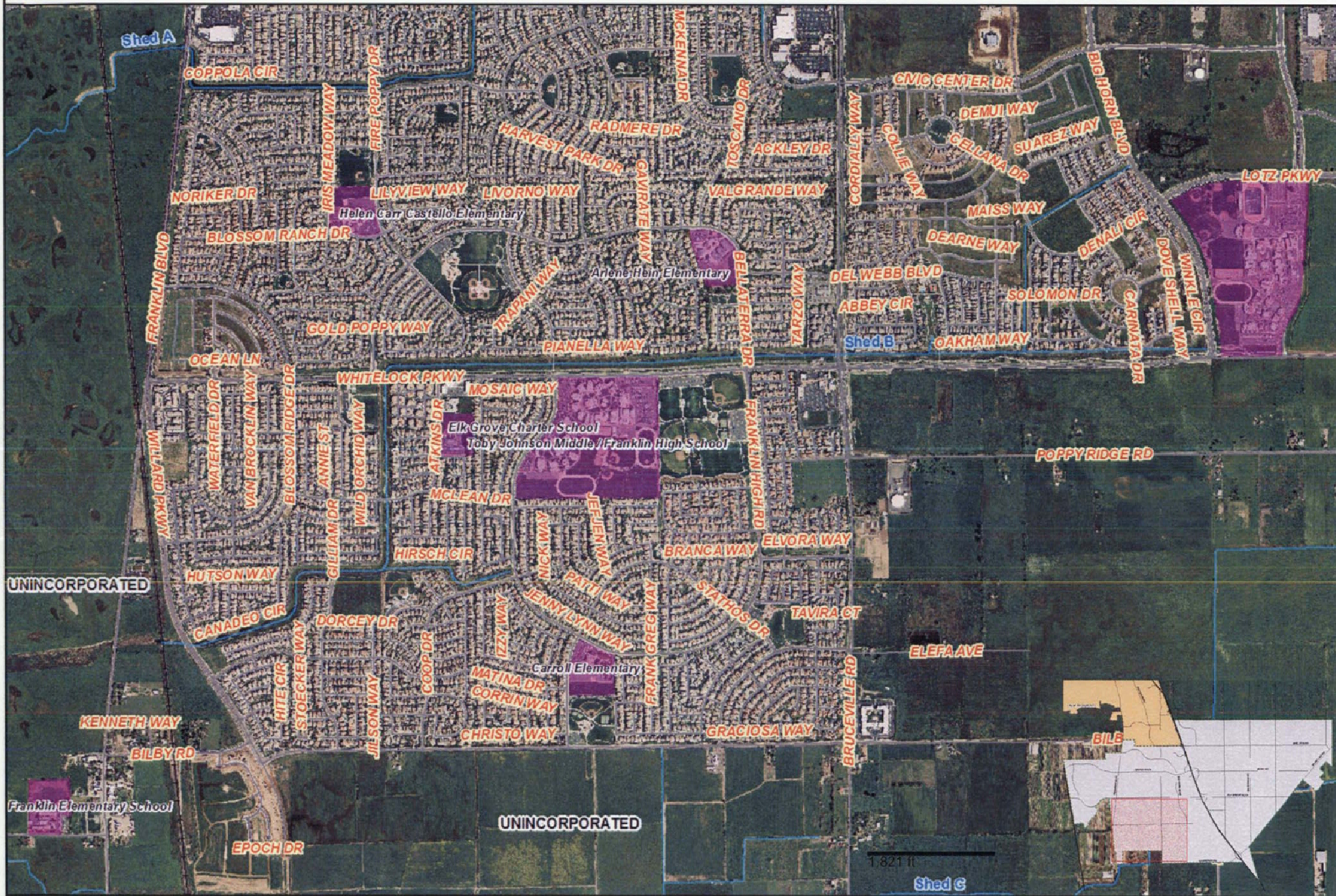
