

RESOLUTION NO. 2014-24

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SUB-RECIPIENT
AGREEMENT WITH THE SACRAMENTO REGIONAL TRANSIT DISTRICT (SRTD)
AND SUBMIT FOR ALLOCATION TOTALING \$687,746 FOR THE REHABILITATION
OF SIX TRANSIT BUSES AND THE PURCHASE OF THREE PARATRANSIT
VEHICLES**

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and

WHEREAS, the City has been awarded Federal Transit Administration Section 5339 Bus and Bus Facilities funding to implement and support transit capital projects; and

WHEREAS, the Sacramento Regional Transit District has been awarded \$687,746 of Federal Transit Administration Section 5339 Bus and Bus Facilities for the rehabilitation of six transit buses and the purchase of three paratransit vehicles; and

WHEREAS, the Sacramento Regional Transit District will pass funds to the City to reimburse costs associated with the rehabilitation of six transit buses and the purchase of three paratransit vehicles as agreed upon in the sub-recipient agreement.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute the sub-recipient agreement and submit for allocation totaling \$687,746 with the Sacramento Regional Transit District for the rehabilitation of six transit buses and the purchase of three paratransit vehicles in substantially the form as attached.
