

**RESOLUTION NO. 2014-67**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE POLICE OFFICE SPACE AND CITY HALL ENTRANCE DOORS  
PROJECT AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE  
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE  
SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on June 12, 2013, the City Council authorized the award of a construction contract to Peterson Developments for the Police Office Space and City Hall Entrance Doors Project (Capital Improvement Project ID WFM002 / WFM003) (the "Project"); and

**WHEREAS**, the Project included refurbishment of office space at the City Corporation Yard Warehouse, installation of chain link fencing, installation and replacement of vehicle overhead doors and replacement of the City Hall swinging doors with automated sliding doors; and


**WHEREAS**, Peterson Developments has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Peterson Developments.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Police Office Space and City Hall Entrance Doors Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
