POLICE EXECUTIVE RESEARCH FORUM (PERF) IN THE AMOUNT OF \$45,946**



**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the carry-over of previously approved Fiscal Year 2012-13 grant funds in the amount of \$45,946 through Fiscal Year 2013-14 or fiscal year of final invoice.


