**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO DELEGATE TRANSIT DIVISION STAFF
TO APPLY FOR FY 2014 FEDERAL TRANSIT ADMINISTRATION (FTA) FUNDS FOR
LOCAL AND COMMUTER E-TRAN SERVICE OPERATIONS
IN THE AMOUNT OF \$980,622**

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and


WHEREAS, the City has been authorized to apply for Federal Transit Administration Section 5307 Urbanized Area Formula Grant funding to implement and support transit operations; and

WHEREAS, the Sacramento Area Council of Governments has approved the Sacramento Urbanized Area 5307 and 5339 programming recommendations for FY 2014 at their March 20, 2014, Board meeting; and

WHEREAS, the Sacramento Area Council of Governments has identified \$980,622 for Elk Grove in the Sub-allocation Split Letter for the Sacramento Urbanized Area for FY 2013-14.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to delegate Transit Division Staff to apply for FY 2014 Federal Transit Administration (FTA) funds for local and commuter e-tran service operations in the amount of \$980,622.




