

RESOLUTION NO. 2014-164

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE AMENDED FISCAL YEAR 2013-2014 TRANSPORTATION DEVELOPMENT ACT (TDA) CLAIM AND THE FISCAL YEAR 2014-2015 TDA CLAIM, AND AUTHORIZING SUBMISSION BY THE CITY MANAGER, OR HER DESIGNEE, TO THE SACRAMENTO AREA COUNCIL OF GOVERNMENTS (SACOG) FOR LOCAL TRANSPORTATION FUNDS (LTF) AND STATE TRANSIT ASSISTANCE FUNDS (STA)

WHEREAS, the State of California enacted the Transportation Development Act (TDA) in 1972 to provide funds for transportation needs each fiscal year; and


WHEREAS, the Sacramento Area Council of Governments (SACOG) is designated as the Regional Transportation Planning Agency for the four county metropolitan area, which includes the City of Elk Grove, to receive claims for approval pursuant to the TDA rights and regulations; and

WHEREAS, SACOG has State Transit Assistance (STA) Funds and Local Transportation Funds (LTF) available for the City of Elk Grove to claim for Fiscal Years 2013-2014 and 2014-2015.

NOW, THEREFORE, BE IT RESOLVED that the City Council authorizes the City Manager, or her designee, to submit necessary claim forms to the Sacramento Area Council of Governments (SACOG) for Local Transportation Funds and State Transit Assistance funds.

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager, or her designee, to make any necessary budget amendments, transfers, accounting entries, and claim amendments to carry out the City Council's policies and directives pertaining to this matter.


