

**RESOLUTION NO. 2014-183**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE SHELDON ROAD – BADER ROAD CULVERT REPLACEMENT  
PROJECT AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND  
THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO  
COUNTY RECORDER**

**WHEREAS**, on October 23, 2013, the City Council authorized the award of a construction contract to B & M Builders, Inc. (the "Contractor") for the Sheldon Road-Bader Road Culvert Replacement Project, (Capital Improvement Project ID WDR002/WDR003) (the "Project"); and

**WHEREAS**, the Project replaced three existing, undersized pipe road culverts: one on Sheldon Road and two on Bader Road. The Project also consisted of regrading the adjoining ditches.; and


**WHEREAS**, B & M Builders, Inc. has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released B & M Builders, Inc.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Sheldon Road-Bader Road Culvert Replacement Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


