WHEREAS, the responsible maintenance of the City's records includes adoption policy for the retention and disposition of records; and

WHEREAS, California Government Code Section 34090 requires the legislative body to approve policy for the disposition of records that are no longer required, which it has done through Resolution No. 2012-8 adopted January 25, 2012; and

WHEREAS, in accordance with Elk Grove City Council Resolution No. 2012-8, Code Enforcement Division physical records older than three years beyond the date the matter was closed can be disposed of as no longer being required; and

WHEREAS, Code Enforcement has identified qualifying records for destruction as well as converted the physical case files to an electronic format to keep in perpetuity.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove hereby:

- 1) The records identified at Exhibit A are no longer required.
- 2) The City Attorney has given written consent to the destruction of the records identified and the destruction of those records is hereby authorized.
- 3) The City of Elk Grove Code Enforcement Division may destroy archived records kept longer that the three years beyond the life of the case required by the California Government Code and Elk Grove City Council Resolution No. 2012-8.
