

RESOLUTION NO. 2014-280

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FY 2014-15 ANNUAL BUDGET AND THE FY 2014-19 CAPITAL
IMPROVEMENT PLAN FOR \$100,000 TO ASSIST THE SENIOR CENTER OF ELK
GROVE WITH CONCEPTUAL DESIGN SERVICES AND FEASIBILITY STUDY**

WHEREAS, over 40,000 Elk Grove residents are age fifty and older, and an additional 23,000 residents will become eligible for the senior services within the next decade; and


WHEREAS, the Senior Center of Elk Grove provides a variety of fellowship, services, technology, fitness and arts activities to its members daily in an 11,000 square feet facility; and

WHEREAS, the Senior Center of Elk Grove has determined it's facility on Sharkey Avenue is inadequate in meeting the current and future needs of Elk Grove's senior population; and

WHEREAS, the Senior Center of Elk Grove will develop a conceptual design and feasibility study to identify a preferred solution and has requested the City's assistance therewith.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove amends the FY 2014-15 Annual Budget and the FY 2014-19 Capital Improvement Plan to appropriate \$100,000 to Project WCC0010 Senior Center from Fund 344 CFD 2005-1 (Laguna Ridge).


