

**RESOLUTION NO. 2014-212**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE LAGUNA CREEK WEIR REPAIR, EAST OF LEWIS STEIN PROJECT PROJECT (CAPITAL IMPROVEMENT PROJECT ID WDR005) AS COMPLETE, AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on May 14, 2014 the City Council authorized the award of a construction contract to Thunder Mountain Enterprises, Inc. for the Laguna Creek Weir Repair, East of Lewis Stein Project (Capital Improvement Project ID WDR005) (the "Project"); and

**WHEREAS**, the Project repaired and reconstructed the existing Laguna Creek overflow weir; and


**WHEREAS**, Thunder Mountain Enterprises, Inc. has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Thunder Mountain Enterprises, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Laguna Creek Weir Repair, East of Lewis Stein Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


